# **GLOBAL AI LAWS - OVERVIEW**

#### UK

- AI (Regulation) Bill (Private Members' Bill) (not proceeding due to the general election but due to be reintroduced following this)
- The current government position published in January 2024
- The government response to white paper published in January 2024 indicates that the government does not intend to introduce legislation to regulate AI at this time, but expects regulators to regulate AI use via existing laws, including the UK GDPR.
- The main opposition party has stated that if it is successful in the general election it will introduce binding regulation on the companies developing the most powerful Al models.
